### Overview

The Jordanian Integrity and Anti-Corruption Commission, in cooperation with the Ministry of Health and with the support of the United Nations Development Programme (UNDP), are organizing a workshop titled "**Towards Implementing Corruption Risk Management in the Health Sector".** The workshop will take place in Amman between 15-17 December 2024, with support from the Korea International Cooperation Agency (KOICA) as part of its regional partnership with UNDP on Anti-Corruption and Integrity in Arab Countries.

The workshop is part of ongoing efforts towards implementing corruption risk management in the health sector in Jordan, complementing the efforts of the Jordanian Integrity and Anti-Corruption Commission (JIACC). It aligns with the implementation of the <u>Updated National Integrity</u> <u>and Anti-Corruption Strategy (2020-2025)</u> and paves the way for similar initiatives in other sectors, such as water. This workshop aims to enhance participants' knowledge and capacities in implementing the Sectoral Corruption Risk Management Methodology (SCRM) developed by UNDP, which has been successfully used in multiple countries worldwide. It will also provide technical assistance and guidance on adapting this methodology to the health sector, drawing on international standards, best practices, and lessons from similar initiatives, while offering a platform for discussions on the most effective ways to implement it within the Jordanian context.

Participants will include representatives from the Ministry of Health, relevant health sector authorities, as well as officials from the Jordanian Integrity and Anti-Corruption Commission, the Audit Bureau, and international and regional experts. This participation emphasizes the importance of applying systematic and scientific approaches to governance in the health sector and the need for integrated efforts to mitigate corruption risks. These efforts are key to broader initiatives aimed at strengthening public sector governance and advancing sustainable development. Specifically, this effort aligns with the 2030 Agenda for Sustainable Development, at the interconnection between SDG 3 (Good Health and Well-being) and SDG 16 (Peace, Justice, and Strong Institutions), and the significant role of the health sector in addressing health security and climate action.
